WHEREAS, the Mark is registered with the USPTO and has been assigned to the Assignor with such offices;





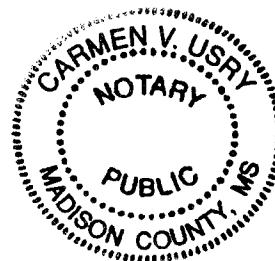
