TRADEMARK ASSIGNMENT**

**THIS TRADEMARK ASSIGNMENT** (this "Assignment") is made and entered into as of the 21<sup>st</sup> day of November, 2006, by **GST SPORTS, INC.**, a Missouri corporation located at 1000 Country Club Road, St. Charles, Missouri 63303 ("Assignor"), in favor of **THE RIVER CITY RAGE, L.L.C.**, a Missouri limited liability company located at 2002 Arena Parkway, St. Charles, Missouri 63303 ("Assignee").

**RECITALS**

**A.** Assignor is the owner of the trademarks, including the United States federal trademark registration and applications therefor, listed on Exhibit A attached hereto and incorporated herein by this reference (collectively, the "Marks"), together with the goodwill of the business symbolized thereby and all common law rights associated therewith.

**B.** Assignor desires to sell, transfer and assign to Assignee, and Assignee is desirous of acquiring from Assignor, any and all rights that Assignor has in and to the Marks and the registration and applications therefor, together with the goodwill of the business with which the Marks are used and which is symbolized by the Marks and the common law rights associated therewith, along with the right to recover for damages and profits for past infringement thereof.

**AGREEMENT**

**NOW, THEREFORE**, in consideration of the foregoing, and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged by Assignor by its execution hereof, the parties agree as follows:

**1. Assignment.** Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee, all of Assignor's rights, title, and interest of whatever kind in and to the Marks, together with (a) the United States federal registration and applications therefor and all common law rights associated therewith, (b) the goodwill of the business symbolized by the Marks, (c) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks, and (d) all rights to sue for past, present and future infringements or misappropriations of the Marks.

**2. Further Assurances.** Assignor covenants and agrees that it will, whenever so requested by Assignee, execute and deliver such further instruments and perform any other reasonable acts that Assignee may require as may be necessary or convenient for vesting in Assignee the full benefit of all of the rights and premises hereby assigned and provide evidence to support any of the foregoing in the event such evidence is in the possession or control of Assignor.

**3. Right to File for Registration.** Assignor hereby transfers, grants, conveys, and assigns to Assignee the sole and unencumbered right to file for and obtain worldwide

registrations for any or all of the Marks, in any or all of its respective forms, in any and all trademark and service mark classes and categories as are applicable.

4. **Request to the Commissioner.** The Commissioner for Trademarks is hereby respectfully requested to record this Assignment in the United States Patent and Trademark Office and index this Assignment against the files of the registration and applications herein described.

5. **Successors and Assigns.** All provisions of this Assignment are binding upon, inure to the benefit of and are enforceable by or against the parties and their respective successors and permitted assigns.

6. **Effective Date.** This Assignment and all of the terms and conditions herein are effective as of the date first above written. The ongoing covenants of the parties as are set forth herein shall continue in effect until such time as this Assignment is terminated and/or amended by a written instrument signed by both parties hereto, or their respective permitted successors and assigns.

7. **Governing Law.** This Assignment shall be governed by and construed in accordance with the internal laws of the State of Missouri.

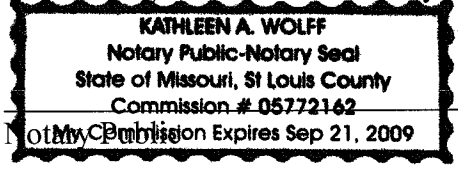

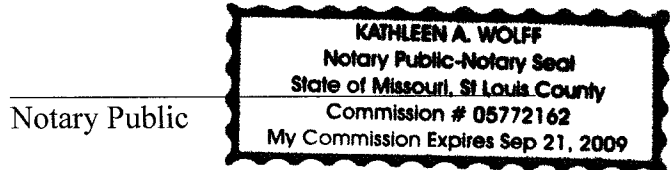
