## INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "**Release**") is made as of November 14, 2006 (the "**Effective Date**"), by Bank of America, National Association, as collateral agent (the "**Collateral Agent**") for each of the Secured Parties (as defined in the Credit Agreement referred to below), in favor of Encore Medical Corporation ("**Encore**") and certain of its subsidiaries (Encore, together with such Subsidiaries, the "**Grantors**").

WHEREAS, Encore Medical Corporation and Encore Medical IHC, Inc. entered into a Credit Agreement dated as of October 4, 2004 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), with Bank of America, as Administrative Agent, Bank of America, as Collateral Agent, and the Lenders party thereto (capitalized terms used herein and not defined shall have the meanings assigned to such terms in the Credit Agreement);

WHEREAS, pursuant to the Credit Agreement and that certain Intellectual Property Security Agreement ("**IP Security Agreement**") dated October 4, 2004, the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors;

WHEREAS, the IP Security Agreement was recorded on November 8, 2004, with the United States Patent and Trademark Office under Reel and Frame number 015953/0090 with respect to patents and Reel and Frame number 3079/0769 with respect to trademarks; and was recorded on November 12, 2004, with the Copyright Office of the United States under volume and document number 3517/246; and

WHEREAS, in accordance with the provisions of the Credit Agreement and the IP Security Agreement, the Collateral Agent now desires to release its security interest in, to and under the patents, trademarks and copyrights identified on Schedules A, B and C attached hereto (the "**Released Intellectual Property**").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent, on behalf of the Secured Parties, hereby releases to the Grantors the security interest in, to and under the Released Intellectual Property granted pursuant to the IP Security Agreement.
2. This Release may be executed in one or more counterparts, and by the Collateral Agent in separate counterparts, each of which when executed shall be deemed an original but all of which taken together shall constitute one and the same agreement. Copies of executed counterparts transmitted by telecopier or other electronic transmission service shall be effective as delivery of an original executed counterpart of this Release.

3. The Collateral Agent authorizes and requests that the Commissioner for Patents, the Commissioner of Trademarks, the Register of Copyrights and any other applicable government officer record this Release.

4. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
