NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

Reference is made to a Security Agreement dated as of January 12, 2006, as amended from time to time prior to the date hereof, (the "Agreement"), by Airborne Health, Inc., a Delaware corporation (the "Borrower") in favor of Union Bank of California, N.A. ("UBOC"), as administrative agent for the lenders (in such capacity, the "Agent"), and a Grant of Security Interest in Trademark Rights dated as of January 12, 2006, as amended from time to time prior to the date hereof, recorded at the United States Patent and Trademark Office at Reel 003239 and Frame 0365 on February 2, 2006 (the "Grant" and together with the Agreement, the "Security Agreement") by the Borrower in favor of the Agent, pursuant to which, inter alia, the Borrower granted to the Agent, for the benefit of certain lenders, a security interest in trademarks including, without limitation, the Marks (as defined in the Agreement) and the trademark registrations and applications listed on Schedule A hereto (the "Trademarks").

Agent hereby notifies, acknowledges to and agrees with the Borrower that the security interest granted by the Borrower to the Agent pursuant to the terms of the Security Agreement is terminated and released as of the date hereof, and the Agent hereby re-assigns and releases to the Borrower and terminates all right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Security Agreement in the Trademarks and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Trademarks; the right to sue for past, present and future infringements, and all rights corresponding thereto associated with such Trademarks.

The Agent's execution of and/or delivery of any documents releasing any security interest or claim in any property of the Borrower as set forth herein is made without recourse, representation, warranty or other assurance of any kind by the Agent, including as to the condition or value of any collateral.
