Partial Release of Lien on Trademarks

WHEREAS, by a certain Amended and Restated Security Agreement, dated as of July 1, 2003 (as amended and supplemented through the date hereof, the "*Agreement*") among Reliant Energy, Inc., formerly known as Reliant Resources, Inc. (the "*Company*"), the subsidiaries of the Company parties thereto (such subsidiaries, together with the Company, the "*Grantors*"), and U.S. Bank National Association (as successor-in-interest to Wachovia Bank, National Association), as collateral trustee (the "*Collateral Trustee*"), the Grantors granted to Collateral Trustee a security interest in and lien on those trademarks owned by Grantors and set forth on Schedule A hereto (the "*Secured Trademarks*");



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Trustee does hereby release its security interest in and lien on the Secured Trademarks and reassigns to the Grantors all right, title and interest of Collateral Trustee in and to such Secured Trademarks.
