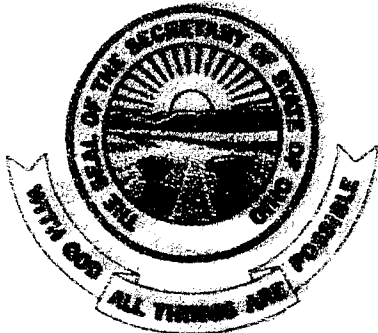

Articles of Incorporation

The undersigned President and Secretary of Andritz Sprout-Bauer, Inc. (the "Corporation"), an Ohio corporation, do hereby certify that,

1. In a writing dated March 6, 1997 and signed pursuant to the provisions of Section 1701.54 of the Ohio Revised Code by the sole shareholder of the Corporation, the following resolution was adopted to amend the articles of incorporation:

RESOLVED, that the sole shareholder of this Corporation hereby amends the corporation's Articles of Incorporation by adopting and approving the Amended Articles of Incorporation attached hereto.

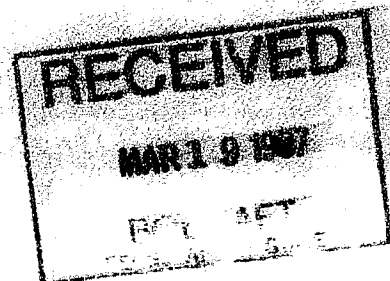
2. A true and complete copy of such Amended Articles of Incorporation is attached hereto as Attachment 1.

AMENDED ARTICLES OF INCORPORATION

OF

ANDRITZ SPROUT-BAUER, INC.

FIRST: The name of the corporation shall be Andritz Inc.

SECOND: The place in the State of Ohio where the corporation's principal office is located is the City of Springfield, County of Clark.

THIRD: The purpose or purposes for which the corporation is formed are to engage in any lawful act or activity for which corporations may be formed under Sections 1701.01 through 1701.99, inclusive, of the Ohio Revised Code as now enacted and as the same may hereafter be amended from time to time (the "Ohio General Corporation Law")

FOURTH: The corporation is authorized to issue up to Five Hundred Thousand (500,000) shares of Common Stock, each of which shall have a par value of \$1.00 per share.

FIFTH: The business of the corporation shall be managed under the direction of the Board of Directors. The number of directors of the corporation shall be fixed from time to time by, or in the manner provided by, the Code of Regulations.

SIXTH: Every statute of the State of Ohio hereafter enacted, whereby rights or privileges of shareholders of a corporation organized under the Ohio General Corporation Law are increased, diminished, or in any way affected, or whereby effect is given to any action authorized, ratified or approved by less than all the shareholders of any such corporation, shall apply to the corporation and shall bind every shareholder to the same extent as if such statute had been in force on the date of the filing of these amended articles of incorporation.

SEVENTH: In the event the code of regulations or the directors' by-laws (if any) of the corporation now or hereafter in effect contain any terms or conditions that are inconsistent with or conflict with any of the terms or provisions of these articles of incorporation, the terms and provisions of these articles of incorporation shall control and shall supersede such conflicting or inconsistent terms of the code of regulations or the directors' by-laws (if any), but such conflict or inconsistency shall not impair, nullify or otherwise affect the remaining terms and provisions of such code of regulations or directors' by-laws, which shall remain in full force and effect.

EIGHTH: No holder of shares of the corporation of any class shall be entitled as such, as a matter of right, to subscribe for or purchase shares of any class, hereafter authorized, or to purchase or subscribe for securities convertible into of

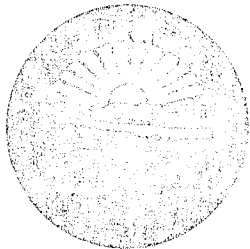
