PATENT, TRADEMARK AND COPYRIGHT RELEASE AND REASSIGNMENT

THIS PATENT, TRADEMARK AND COPYRIGHT RELEASE AND REASSIGNMENT is made as of November 29, 2006, by National City Business Credit, Inc., as Agent ("Agent ").

WITNESSETH:

WHEREAS, Radnor Holdings Corporation, a Delaware corporation ("Radnor"), StyroChem U.S., Ltd., a Texas limited partnership ("SUL"), Wincup Holdings, Inc., a Delaware Corporation ("WHI") and StyroChem Delaware, Inc., a Delaware corporation ("SDI") (Radnor, SUL, WHI and SDI are each an "Obligor" and collectively the "Obligors"), are parties to that certain Patent, Trademark and Copyright Security Agreement dated December 29, 2005 for the benefit of the Agent (for its benefit and the ratable benefit of the Lenders and the Agent) (the "IP Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the IP Agreement), pursuant to which Obligors granted a security interest to Agent in, among other things, the Patent Collateral, the Trademark Collateral and the Copyright Collateral (each as defined herein), as security for certain obligations owing by Obligors to the Agent and Lenders pursuant to that certain Revolving Credit and Security Agreement, dated December 29, 2005 by and among the Obligors, the Guarantors party thereto, Agent and the Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time; and

WHEREAS, the Notice of Security Interest in U.S. Patents in the SDI Patents was recorded by the Assignment Division of the United States Patent and Trademark Office on January 17, 2006 at Reel 017198, Frame 0393;

WHEREAS, the Notice of Security Interest in U.S. Patents in the WHI Patents was recorded by the Assignment Division of the United States Patent and Trademark Office on January 17, 2006 at Reel 017198, Frame 0403;

WHEREAS, the Notice of Security Interest in U.S. Patents in the SUL Patents was recorded by the Assignment Division of the United States Patent and Trademark Office on January 17, 2006 at Reel 017198, Frame 0414;

WHEREAS, the Notice of Security Interest in U.S. Trademarks in the WHI Trademarks was recorded by the United States Patent and Trademark Office on January 17, 2006, at Reel 003245, Frame 0865;

WHEREAS, the Notice of Security Interest in U.S. Trademarks in the SDI Trademarks was recorded by the United States Patent and Trademark Office on February 23, 2006, at Reel 003268, Frame 0435; and

WHEREAS, a Notice of Security Interest in U.S. Copyrights was not recorded in the United States Patent and Trademark Office by the Agent.

WHEREAS, Obligors have requested that Agent release its recorded security interests in the Patent Collateral and Trademark Collateral and reassign the same to Obligors;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Obligors' right, title and interest in and to all of the following (the "Patent Collateral"):

(a) patents and patent applications, including, without limitation, the inventions and improvements described and claimed therein, and those patents listed on Schedule A, attached hereto and made a part hereof, and (a) the reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights relating thereto.

2. Agent hereby releases its security interest in all of Obligors' right, title and interest in and to all of the following (the "Trademark Collateral"):

(a) trademarks, trademark registrations, trade names and trademark applications, service marks, service mark registrations, service names and service mark applications, including, without limitation, the trademarks, trademark registrations, trade names and trademark applications, service marks, service mark registrations, service names and service mark applications listed on Schedule B, attached hereto and made a part thereof, and (a) renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights relating thereto; and

(b) the entire goodwill of each Obligor's business including, but not by the way of limitation, such goodwill connected with and symbolized by the Trademark Collateral.

3. Agent hereby releases its security interest in all of Obligors' right, title and interest in and to all of the following (the "Copyright Collateral"):

(a) copyrights, applications, registrations and recordings in the United States Copyright Office, listed on Schedule C, attached hereto and made a part hereof, and (a) all extensions and renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect to, including, without limitation, damages and payments for past or future infringements thereof, (c) the


right to sue for past, present and future infringements thereof, and (d) all rights relating thereto.

4. Agent hereby reassigns, grants and conveys to Obligors, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Patent Collateral, Trademark Collateral and the Copyright Collateral, and the goodwill of Obligors' business connected with the use of and symbolized by the Trademark Collateral.
