## ASSIGNMENT OF TRADEMARKS

**THIS ASSIGNMENT OF TRADEMARKS** is made and entered by and between IGT, a Nevada corporation with a principal place of business at 9295 Prototype Drive, Reno, Nevada 89521 ("Assignee"), and King Show Games Inc., a Minnesota corporation that converted from a limited liability company to a corporation under Minnesota law but is still the same legal entity with its principal place of business at 130 Cheshire Lane, Minnetonka, Minnesota 55305 ("Assignor").

**WHEREAS**, Assignor is the sole and exclusive owner of all right, title and interest in, to the trademarks, trademark registrations and applications for the Delivered Games as set forth in Schedule A (the "Trademarks");

**WHEREAS**, pursuant to the 32<sup>nd</sup> AMENDMENT TO AGREEMENT between Assignor and Assignee, Assignor is transferring certain of its assets, including the Trademarks, to Assignee;

**WHEREAS**, Assignee is the successor to the ongoing and existing portion of the business of Assignor to which the Trademarks pertain;

**WHEREAS**, Assignee wishes to acquire and Assignor wishes to assign all right, title and interest in and to the Trademarks;

**ACCORDINGLY**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Assignor does hereby sell, assign and transfer unto Assignee all right, title, and interest in and to the Trademarks, together with all common-law rights and goodwill of the business symbolized by the Trademarks, including the registrations, applications and any resulting registrations therefor, as well as any and all claims, demands, causes of action, rights to sue or other rights occasioned from or because of any and all past or present infringement or misappropriation of the Trademarks and the right to collect damages therefor and all income, royalties or payments due as of the date hereof or hereafter. Assignor further agrees that upon request, it shall execute any and all documents necessary to vest all rights, title and interest in and to the Trademarks, the applications and registrations therefor.

This Assignment is binding on Assignor, its successors and assigns, and will inure to the benefit of the Assignee, its successors and assigns. Nothing in this instrument, express or implied, is intended or shall be construed to confer upon, or give to, any person, corporation or entity other than Assignee, its successors and assigns, any remedy or claim under or by reason of this instrument, or any terms, covenants or conditions hereof, and all the terms, covenants and conditions in this instrument shall be for the sole and exclusive benefit of Assignee and its successors and assigns.

This Assignment shall be deemed to have been effective as of July 28, 2006.
