**TERMINATION OF SECURITY AGREEMENT
(TRADEMARKS)**

WHEREAS, ProQuest Business Solutions, Inc., a corporation organized under the laws of Delaware, having an address at 789 Eisenhower Parkway, Ann Arbor, MI 48106 (the "Assignor"), owns federal trademark registrations and applications in the United States Patent and Trademark Office, more particularly described in Schedule 1 annexed hereto and made a part hereof (the "Trademarks");

WHEREAS, Assignor had assigned (the "Assignment") to LASALLE BANK MIDWEST NATIONAL ASSOCIATION, formerly known as Standard Federal Bank, N.A., a national banking corporation, as Collateral Agent (the "Assignee"), and granted to Assignee a security interest in all right, title, and interest of Assignor in and to the Trademarks (the "Collateral") to secure the prompt payment, performance, and observance of certain obligations of Assignor to Assignee (the "Obligations");

WHEREAS, the Assignor's Obligations have been discharged; and

WHEREAS, Assignee desires to terminate the Security Agreement;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee does hereby terminate the Security Agreement dated April 26, 2006 in part, recorded in the U.S. Patent and Trademark Office on May 4, 2006, at reel 3302, frame 0597, and hereby terminates, cancels and releases any and all security interests in and to the Collateral listed on Schedule 1.

Assignee does hereby agree to take all further actions, and to execute and deliver, and to provide Assignor, its successors, assigns or other legal representatives, any and all such documents or other instruments, reasonably requested by Assignor to more fully and effectively effectuate the purposes of this termination.
