## ASSIGNMENT

**THIS ASSIGNMENT** ("Agreement") is entered as of January 1, 2003, by and between **MULBERRY THAI SILKS, INC.** ("Mulberry"), a California corporation, having its principal place of business at 880 Harbour Way South, Richmond, California 94804-3613, and **HENRY JACOBSON, LLC** ("Henry Jacobson, LLC"), a California limited liability company, having its principal place of business at 880 Harbour Way South, Richmond, California 94804-3613.

## RECITALS

**WHEREAS**, Mulberry desires to assign all of its rights, title, interest, and goodwill in and to the property listed in Exhibits A and B attached hereto (the "Intellectual Property") to Henry Jacobson, LLC, and Henry Jacobson, LLC intends to acquire those rights.

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged,

1. Mulberry hereby assigns, agrees to assign, transfers, conveys, and delivers to Henry Jacobson, LLC all of its rights, title, and interest in the Intellectual Property, including the goodwill in and to the Intellectual Property.

2. **THE INTELLECTUAL PROPERTY IS ASSIGNED ON AN "AS IS" BASIS. THE PARTIES EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.**

3. Mulberry agrees to cooperate and assist Henry Jacobson, LLC in recording an assignment of the trademark/service mark registrations and any copyright registrations. Mulberry agrees to assist in the registration process of the Intellectual Property by executing reasonable documents that may be submitted to the United States Patent and Trademark Office, the United States Copyright Office, and any similar offices in other nations, as Henry Jacobson, LLC may reasonably request.

4. This Agreement shall be governed by and construed in accordance with the substantive and procedural laws of the State of California, without giving effect to the conflict of law rules thereof, and shall be deemed to be executed in San Rafael, California. Any legal action or proceeding relating to this Agreement shall be instituted in a state or federal court in San Francisco or San Mateo

County, California. The parties agree to submit to the jurisdiction of, and agree venue is proper in, these courts in any such legal action or proceeding.

5. In the event that any provision of this Agreement shall be held by a court of competent jurisdiction to be invalid, illegal, or unenforceable in any respect in any jurisdiction, such provision shall, as to that jurisdiction, be ineffective to the extent of such invalidity, illegality, unenforceability, without affecting in any way any of the other provisions of this Agreement invalid, illegal, or unenforceable in any other jurisdiction and this Agreement shall be construed in a manner consistent with its intent.

6. This Agreement constitutes the entire agreement and understanding between the parties hereto and supersedes any prior understanding or agreements whether oral or written. This Agreement may not be amended or modified, except as expressly agreed to in writing by both parties.


