WHEREAS, Assignor wishes to assign the Trademark to Assignee and to memorialize said assignment herein.



FURTHER, Assignor hereby covenants and agrees to execute all documents, papers, forms and authorizations, and to perform all other acts which may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Trademark and to otherwise fully effectuate and record this Assignment.
