ASSIGNMENT OF UNITED STATES TRADEMARK REGISTRATION

NOW, THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, the Assignor has sold, assigned and transferred and hereby sells, assigns and transfers unto the Assignee, its successors and assigns, the entire right, title and interest in and to said trademark and said registration therefor, including all goodwill of the business in connection with which said trademark is used, together with all rights and privileges pertaining to said trademark and registration, including all rights of recovery for past, present and future infringement thereof and the right to renew said registration for subsequent terms, the same to be held and enjoyed by the Assignee, its successors and assigns, as fully as the same would have been held and enjoyed by the Assignor had this sale, assignment and transfer not been made. It is the intent of the parties that all rights in the mark be assigned to Assignee, with no rights or privileges retained by Assignor.
