TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Assignment”), effective September 1, 2006, (“Effective Date”) is by and between SEARLES VALLEY MINERALS INC., a Delaware corporation having a principle business address of 9401 Indian Creek Parkway, Overland Park, Kansas 66120 (“SVM”) and SOCIETÀ CHIMICA LARDERELLO S.p.A., a Italian Società Per Azioni having a principle business address of Via Fara Gustavo, 28 I-20124 Milano, Italy (“SCL”).

WHEREAS, SVM is the owner of all right, title and interest in and to the trademark FOLIAREL (the “Trademark”), including, but not limited to, U.S. Trademark Registration number 1,532,474, as well as all common law rights and goodwill of the business symbolized by said Trademark.

WHEREAS, SCL is desirous of acquiring said Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SVM hereby sells, assigns and transfers to SCL, its successors, assigns and legal representatives, all right, title and interest in and to the Trademark, together with the goodwill of the business symbolized thereby, all rights to sue for past infringement of said Trademark, and all causes of action (either at law or equity) with respect thereto, the right of recovery, including but not limited to damages, for such past infringement, and the right to assign or license the rights conveyed herein, the same to be held and enjoyed by SCL for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.

SVM hereby authorizes SCL to record ownership of the Trademark directly in SCL’s own name in any jurisdiction, municipality, or agency, in which recordation is required.

SVM will from time-to-time after the Effective Date, upon request of SCL, execute, acknowledge, and deliver all such further deeds, assignments, transfers, conveyances, powers of attorney and assurances, and take such further action as may be required to carry out the intent of this Assignment, and to transfer and vest title to any trademark being transferred hereunder, and to protect the right, title, and interest in and enjoyment of all the Trademark assigned hereunder.

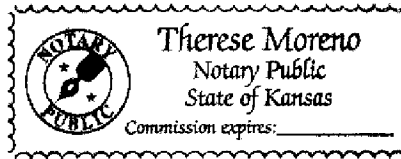
