RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of November 4th, 2006 ("Effective Date") by and between Microporous Products, L.P. (the "Grantor") and Wachovia Bank, National Association, as successor to First Union National Bank (collectively, the "Grantee").

WHEREAS, pursuant to the terms and conditions of that certain Amended and Restated Security Agreement by and between Grantor and Grantee dated October 6, 2000 (the "Security Agreement"), Grantor granted to Grantee a security interest in and to all of Grantor's right, title and interest in and to all trade names, trademarks and service marks, logos, trademark and service mark registrations, and applications for trademark and service mark registrations, including, without limitation, all renewals of trademark and service mark registrations, all rights corresponding thereto throughout the world, the right to recover for all past, present and future infringements thereof, all other rights of any kind whatsoever accruing thereunder or pertaining thereto, together, in each case, with the product lines and goodwill of the business connected with the use of, and symbolized by, each such trade name, trademark and service mark, whether now owned or hereafter acquired (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, the United States applications for trademark registration set forth on Schedule B attached hereto and the foreign trademark registrations set forth on Schedule C attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on February 15, 2001 at Reel/Frame 2242/0791; and

WHEREAS, except for indemnification obligations that by their terms survive, Grantor is released from all obligations under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interest it has against the Trademarks.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
