TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of December 6, 2006, by and between Singlecast Technologies, Inc., a Delaware corporation with a principal place of business at 590 Means Street Atlanta, Georgia 303018 ("Assignor"), and Zantaz, Inc., a California corporation with a principal place of business at 5758 West Las Positas Blvd., Pleasanton, California 94598 ("Assignee").

Assignor does hereby irrevocably assign, sell and transfer to Assignee, its successors and assigns, all of Assignor's right, title, and interest in and to said Marks, including (i) the registrations of and applications for registration of the Marks; (ii) the goodwill of the business symbolized by and associated with the Marks and the registration thereof; and (iii) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with any and all past infringement or dilution of or damage or injury to the Marks or the registration thereof or such associated goodwill.
