TRADEMARK ASSIGNMENT

This Trademark Assignment is from Dorothy Ann Weems ("Weems"), a resident of Alabama, having a mailing address of P.O. Box 5153, Huntsville, Alabama 35814, to NarroWay Productions, Inc. (hereinafter "NarroWay"), a South Carolina corporation, having a business address of 3346 Highway 21, Fort Mill, South Carolina 29715.

WHEREAS, Weems desires to convey to NarroWay, her entire rights, title and interest in and to the NARROW WAY PRODUCTIONS mark and to U.S. Trademark Registration No. 2,836,341, which registered on April 27, 2004, for "entertainment services, namely providing production and performance of live and prerecorded television shows in the field of comedy, drama, musicals, variety, talk shows—films featuring comedy, drama and documentaries – production and performance of live stage plays in the nature of comedy and drama, and production of video recordings featuring comedy, drama, musical and variety" in International Class 41, together with the good will of the business associated therewith and the right to sue for past infringements thereof; and

WHEREAS, NarroWay desires to acquire Weem's entire rights, title and interest in and to said mark and registration, together with the good will of the business associated therewith and the right to sue for past infringements thereof;

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Weems hereby sells, transfers, and assigns to NarroWay her entire rights, title, and interest in and to the NARROW WAY PRODUCTIONS mark and U.S. Registration No. 2,836,341, together with all common law rights therein and all of the good will of the business associated therewith and the right to sue for any past infringements thereof.
