**DECLARATION OF CHRISTINA LONDON IN SUPPORT OF CORRECTING  
ERRONEOUS CHANGE OF NAME SUBMISSION**

I, Christina London, declare as follows:

1. I am a paralegal with the law firm of Edwards Angell Palmer & Dodge LLP, and am over 18 years of age. I am submitting this Declaration in support of correcting an erroneous change of name submission, as required by TMEP §503.06(c).

2. On December 6, 2006, I erroneously recorded a Change of Name document with the U.S. Patent and Trademark Office on the 21 trademarks mentioned in the attached schedule. This January 2, 2005 change of name document was recorded at Reel 003440 and Frame 0828 on December 6, 2006, transferring the ownership of the 21 registered trademarks listed on the attached schedule from Uniflex, Inc. to UFI Liquidating Corporation (see attached Notice of Recordation).

3. These trademarks were initially applied for by Uniflex, Inc. Uniflex, Inc. then entered into an Asset Purchase Agreement with Uniflex Holdings, Inc. on December 16, 2004, nearly one month before the name change was effectuated for Uniflex, Inc. This Asset Purchase Agreement was recorded with the U.S. Patent and Trademark Office on December 6, 2006 at

Reel 003439 and Frame 0719. Therefore, the assignment abstract of title for each of the 21 registered trademarks should reflect Uniflex Holdings, Inc. as the current and correct owner of record.

4. The chain of title should not be considered altered by the incorrect name change filed at Reel 003440 and Frame 0828 on December 6, 2006. Uniflex Holdings, Inc. is the correct owner of record for each of the trademarks listed in the attached schedule.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct and that this declaration is executed this 11th day of December, 2006, at Stamford, Connecticut.
