ASSIGNMENT OF A TRADEMARK REGISTRATION

WHEREAS, Azo Company, Inc., a California corporation, has adopted and used and is using and is the Owner of the trademark AZO and DESIGN (the "Mark") and the registration for the Mark registered February 15, 2005, identified U.S. Registration No. 2,926,452.

WHEREAS, Storm Products, Inc. (Assignee), a Utah corporation, doing business at 1615 South 9th West, Brigham City, Utah 84302, is desirous of acquiring the Mark, the Registration therefore and all rights and goodwill appertaining to said Mark;

IN CONSIDERATION of the sum of \$10.00 (Ten Dollars) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, AZO Company, Inc. does sell, assign and transfer to Storm Products, Inc., the entire right, title and interest in and to: (a) the Mark for the United States and all foreign countries, including all common law rights appertaining thereto; (b) U.S. Trademark Registration No. 2,926,452, including all priority rights related thereto; (c) that part of the goodwill of the business connected with the use of and symbolized by the Mark; and (d) Azo Company's entire right, title and interest in and to all claims for damages by reason of past or present infringement of the trademark by any party or parties, with the right to sue for and collect the same for Storm Products, Inc.'s own use and benefit.

Azo Company, Inc. authorizes the Assignee to apply for and receive any and all United States and foreign registrations relating to said Mark in its own name;

Azo Company, Inc. authorizes and requests the issuing authority to issue any and all United States and foreign registrations granted on said Mark to and in the name of the Assignee;

Azo Company, Inc. warrants and covenants that no assignment, grant, mortgage, license or other agreement or encumbrance affecting the rights and property herein conveyed has been or will be made or entered into by the undersigned, and that the full right to convey the same as herein expressed is possessed by the undersigned;

Azo Company, Inc. covenants, and when requested and at the expense of the Assignee, to carry out in good faith the intent and purpose of this assignment to execute all rightful assignment, powers of attorney and other papers; and generally to do everything possible which the Assignee shall consider desirable for vesting title to said Mark, Registration and goodwill and claims from damages in the Assignee, and to secure, maintain, defend and enforce valid and enforceable protection for said Mark.

Azo Company, Inc. agrees and acknowledges that the sale, assignment and transfer of rights and property set forth herein is and shall be irrevocable and binding upon the heirs, assigns, representatives and successors of Azo Company, Inc. and extend to the successors, assigns and nominees of Storm Products, Inc.
