**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This RELEASE, dated as of December 7, 2006, is made by JPMorgan Chase Bank, N.A., as First Lien Administrative Agent (“JPMorgan”), in favor of Worldspan, L.P. (“Worldspan”) as follows:

**WITNESSETH**

WHEREAS, pursuant to the Security Agreement dated February 11, 2005 (“Security Agreement”), and recorded with The United States Patent and Trademark Office on February 17, 2005 at Reel/Frame No. 3032/0343 in connection with the Trademarks; recorded with The United States Patent and Trademark Office on April 21, 2006 at Reel/Frame No. 017509/0046 in connection with the Patents; recorded with The Copyright Office on February 23, 2005 at Microfilm No. V3521 P385, Worldspan granted JPMorgan a security interest in its trademarks and all applications and registrations therefore, including goodwill (the “Trademark Collateral”), in its patents and all applications therefor, technology and know-how, and all licenses, royalties and other monies relating thereto (the “Patent Collateral”), and in its copyrights and all applications and registrations therefore (the “Copyright Collateral”);

WHEREAS, Worldspan has requested that JPMorgan release its security interest in all right, title and interest of Worldspan in and to the trademarks and all applications and registrations therefore, including goodwill; in and to the patents and all applications therefor; and in and to technology and know-how, and all licenses, royalties and other monies relating thereto, to the copyrights and all applications and registrations therefore, set forth in Schedule A.

NOW, THEREFORE, JPMorgan, without recourse, representation or warranty and at Worldspan’s sole cost and expense, hereby RELEASES all of its right, title and interest in and to the security interests granted to JPMorgan pursuant to the Intellectual Property Security Agreement in each of the trademarks, patents and copyrights set forth in Schedule A, attached hereto and incorporated herein by reference and the registrations of and applications for said trademarks, patents and copyrights.

JPMorgan agrees to provide Worldspan upon its request therefor with any information and additional authorization necessary to effect the release of JPMorgan’s security interest in the Released Trademark, Patent and Copyright Collateral.


