

TO THE

THE UNDERSIGNED, pursuant to the District of Columbia Nonprofit Corporation Act hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is: The Association of Trial Lawyers of America, a Corporation.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Nonprofit Corporation Act:

Article FIRST is amended to read as follows:

“FIRST: The name of the Corporation is: American Association for Justice.”

THIRD: The amendment was adopted at a meeting of members on July 19, 2006, at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.


