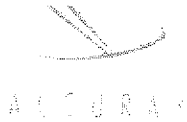

We have reviewed Accuray's financial obligations and determined that there is currently a UCC financing statement on behalf of President (BVI) International Investment Holdings Ltd. on some of Accuray's assets including, among others, US Patents 5,207,223; 5,427,097; 5,430,308; 6,144,875; 6,501,961; 20030120141 and US Trademark No. 2159142. We understand that his UCC financing statement was filed in connection with our obligations under a US\$6 million line of credit (the "Loans") under a Security Agreement (the "Secured Loan Agreement"), date July 28, 2002.
