ASSIGNMENT AGREEMENT

This Assignment Agreement is entered into 23rd day of February 2006, by and between Finanz St. Honoré, B.V., a Netherlands corporation (“Assignor”) with a registered office at Rakin 55, 1012KK Amsterdam, The Netherlands and Disney Enterprises, Inc., a Delaware corporation (“Assignee”) with its principal place of business at 500 South Buena Vista Street, Burbank, CA 91521.

WHEREAS:

- (A) The Assignor is the legal and beneficial owner of the trademarks Tinkerbell, Big T, and Tink and of the trademark registrations listed in Schedule “A” to this Assignment Agreement and related rights as defined herein (hereinafter the “Assigned Trademarks”) and intends, subject to the terms and conditions of this Assignment Agreement, to assign the legal and beneficial ownership in the Assigned Trademarks and some of the related rights thereto, to the Assignee with full title guarantee; and
- (B) The Assignee wishes to purchase from Assignor all rights in and title to the Assigned Trademarks, together with the goodwill associated with the Assigned Trademarks.

IT IS HEREBY AGREED as follows:

**1. ASSIGNMENT**

- 1.1 For valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby sells, assigns, transfers and conveys with full title guarantee to the Assignee, its successors and assigns:
  - a. Assignor’s right, title and interest in and to the Assigned Trademarks in the United States and all of the foreign countries listed in Schedule A; and,
  - b. Any and all goodwill, common law rights and other rights arising under applicable law related to the Assigned Trademarks.
  - c. The right to recover damages and/or profits arising from past infringement of the Assigned Trademark and the right to sue for and receive same in Assignee’s name.
- 1.2 The Assignor hereby agrees to execute specific confirmatory assignment and other supplementary documents (as may be required) in favor of the Assignee, for each of the countries in which there are Assigned Trademarks detailed in the Schedule A in order to record the assignment of the Assigned Trademarks on the Registers of the countries detailed in the Schedule.
- 1.3 The Assignor, at the request of Assignee, further agrees to co-operate and assist the Assignee in any legal requirements relating to the status, validity or enforceability of the


Assigned Trademarks, including providing Assignee with any information regarding use of the Assigned Trademarks by Assignor, its affiliates and/or licensees in connection with the prior manufacture, promotion, sale and advertising of any products bearing the Assigned Trademarks.


1.4 The rights and obligations stated in and/or arising from this Assignment Agreement shall extend to and be binding upon all successors, licensees and assigns of the parties hereto.
