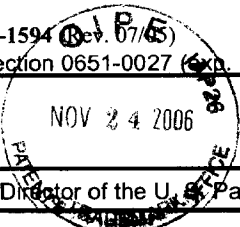

**TRADEMARK ASSIGNMENT**

This Trademark Assignment is entered into as of the 26<sup>th</sup> day of April, 2005, by and between Mandalay Resort Group, a Nevada Corporation and subsidiary of MGM MIRAGE, located at 3950 Las Vegas Blvd South, Las Vegas, Nevada 89119 ("MRG"), and Detroit Entertainment, L.L.C., a Michigan limited liability company, located at 1922 Cass Avenue, Detroit, Michigan 48226 ("Detroit Entertainment").

WHEREAS, MRG is the owner of record of U.S. Trademark Registration No. 2,870,900 for SIGNATURE CLUB ELITE for casino services (registered August 10, 2004) and U.S. Trademark Registration No. 2,680,587 for SIGNATURE CLUB (AND DESIGN) for casino services (registered January 28, 2003) ("Signature Club Marks");

WHEREAS, Detroit Entertainment has been using the Signature Club Marks in its capacity as a subsidiary of MRG and now desires to acquire all of MRG's right, title and interest in and to the Signature Club Marks;

WHEREAS, MRG is willing to transfer its right, title and interest to the Signature Club Marks to Detroit Entertainment provided that Detroit Entertainment consents to the use and registration by MGM Grand Hotel, LLC, a Nevada limited liability company and subsidiary of MGM MIRAGE, of the marks THE SIGNATURE and THE SIGNATURE AT MGM GRAND ("MGM Signature Marks") only in connection with hotel and condo services and excluding any physical use of the MGM Signature Marks in the State of Michigan but including use of the MGM Signature Marks on the Internet (as provided for in the Consent Agreement executed concurrently herewith);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties, MRG and Detroit Entertainment agree as follows:

1. Assignment of Signature Marks: MRG hereby assigns all of its right, title and interest to the Signature Club Marks, including any accompanying goodwill, and any claim or cause of action for infringement of the Signature Club Marks, and any domain names containing the phrase "signature club," to Detroit Entertainment.
2. Warranty and Representations: MRG makes no warranties or representations of any kind relating to validity or non-infringement of the Signature Club Marks.
3. Binding Agreement: This Assignment shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.
