BETWEEN

1. **Doncasters Limited**, a British company of 28-30 Derby Road, MELBOURNE, Derbyshire DE73 1FE United Kingdom (hereinafter referred to as "**Doncasters**") and
2. **Paralloy Limited**, a British company of 28-30 Derby Road, MELBOURNE, Derbyshire DE73 1FE United Kingdom (hereinafter referred to as "**Paralloy**")

RECITALS

- A. Whereas Doncasters is the registered applicant in respect of certain patent applications further details of which are in Schedule 1 (hereinafter called the "**Patent Applications**")
- B. Whereas Doncasters is the registered applicant/proprietor in respect of certain trade mark registrations and applications for registration further details of which are in Schedule 2 (hereinafter called the "**Trade Marks**")
- C. Whereas Doncasters and Paralloy are part of a group of companies ultimately sharing the same common ownership and whereas Paralloy operates the business of such group responsible for the development of the inventions resulting in the Patents Applications and the use of the Trade Marks
- D. Now the parties have agreed to execute this Assignment so that the Patent Applications, the inventions claimed in the Patent Applications (hereinafter called the "**Inventions**") and the Trade Marks are vested in Paralloy

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. Doncasters hereby assigns to Paralloy and Paralloy hereby accepts an assignment of Doncasters entire right title and interest in and to the Patent Applications, the Inventions and the Trade Marks including without limitation:

- a. Paralloy's entire right to be absolutely entitled to any patent granted on any of the Patent Applications for the full term of such patents and its entire to apply for, be granted and hold patents for the Inventions in or for any part of the world (including without limitation its right and title to any and all future foreign or PCT applications and national/regional phase applications patents derived from any of the Patent Applications and all future PCT applications as well as any and all divisional and continuation applications) and the right to priority;
 - b. the right to recover and take all such proceedings as may be necessary for the recovery of damages or other forms of relief in respect of all infringements of the Inventions and/or the Patent Applications and/or the Trade Marks whether committed before or after the date of this Assignment.
 - c. All goodwill attached to the Trade Marks
2. Doncasters hereby agrees that it will at the expense of Paralloy, promptly execute and sign all such instruments applications documents and do all such acts and things as may reasonably be required by the Paralloy to enjoy the full benefit of the property and rights hereby assigned (including without limitation executing any and all forms required in connection with the filing and prosecution of patent applications and otherwise assisting with the prosecution to grant of the Patent Applications and any future applications claiming priority therefrom)
 3. This Agreement shall be governed by and interpreted in accordance with the laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts

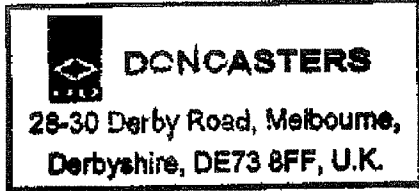
