At the request and expense of Assignee, but with no additional compensation to Assignor, Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents that Assignee may require in order to transfer all of Assignor's rights, title and interest in and to the Trademark and Trademark registrations and applications to Assignee, its successors assigns.

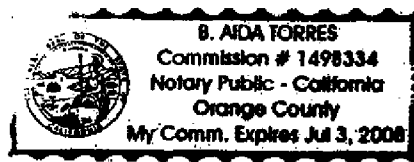
