

ARTICLES OF INCORPORATION
FOR GPX, INC.**

Pursuant to the provisions of The General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

1. The name of the corporation is **GPX, Inc.** (the "Corporation").

The name under which it was originally organized was **Dick Proctor, Imports, Inc.**
2. An amendment to the Corporation's Articles of Incorporation was adopted by the shareholders as of October 24, 2006.
3. Article One of the Corporation's Articles of Incorporation is amended to read as follows:
