**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT
AND
REASSIGNMENT OF TRADEMARK**

This Release of Trademark Collateral Assignment and Reassignment of Trademark is made as of January 1, 2006, between THE CIT GROUP/COMMERCIAL SERVICES, INC., a New York corporation (as assignee of Congress Financial Corporation pursuant to an amendment and assignment of Trademarks Collateral Assignment and Security Agreement dated June 1, 1999 and recorded August 4, 1999 in the trademarks records of the United States at Reel 001939 Frame 0644) ("Lender") and The Basketball Marketing Corporation, a Delaware corporation ("Borrower").

WHEREAS, Borrower and Lender entered into a certain Factoring Agreement, dated April 11, 1997, as amended (the "Agreement"); and




