TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is entered into on the 15 of December, 2006, by STARBASE CORPORATION., a Delaware corporation with a principal address of 20450 Steven Creek Blvd, Suite 800 Cupertino CALIFORNIA 9501-42265 ("Assignor"), in favor of BORLAND SOFTWARE CORPORATION, a Delaware corporation, with a principal address of 20450 Steven Creek Blvd, Suite 800 Cupertino CALIFORNIA 9501-42265 ("Assignee").

Assignor, in connection with its prior sale of certain assets to Assignee, desires to formalize the transfer to Assignee all of Assignor's right, title, and interest in the trademark EXPRESSROOM (the "Mark"), together with the goodwill that Assignor has developed in the Mark.

NOW, THEREFORE, for the sum of one dollar and other good and valuable consideration offered by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees as follows:

1. Assignor hereby conveys, assigns, sells, and transfers to Assignee and its successors and assigns Assignor's entire right, title, and interest in and to the Mark, together with the goodwill that Assignor has developed in the Mark, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its subsidiaries, affiliates, successors, assigns, licensees, and legal representatives, as such rights would have been held and enjoyed by Assignor had this Assignment not been made. Without limitation of the foregoing, the rights hereby assigned to Assignee include the federal registration associated with the Mark identified by U.S. Registration No. 2,359,771. The rights assigned hereunder also specifically include the right to sue for any and all past infringements of the Mark, and to receive any and all damages awarded as a result of any such claim.

2. This Assignment is binding upon the parties and their respective successors, assigns, trustees, and representatives.
