TRADEMARK ASSIGNMENT

WHEREAS, **CANADIAN FOREST PRODUCTS LTD.** (hereinafter the “**Assignor**”) is a corporation incorporated under the laws of the Province of British Columbia, having a business address of 1500 - 550 Burrard Street, Vancouver, British Columbia, CANADA V6C 2C1, and having moved as of March 22, 2005 to the new business address of 100 – 1700 West 75th Avenue, Vancouver, British Columbia, Canada, V6P 6G2;

WHEREAS, **CANFOR PULP LIMITED PARTNERSHIP** (hereinafter the “**Assignee**”), is a Canadian limited partnership subsisting under the laws of the Province of Manitoba, having a business address of 100 – 1700 West 75th Avenue, Vancouver, British Columbia, Canada, V6P 6G2;

WHEREAS, the Assignor did assign and transfer to the Assignee, as part of a written asset transfer agreement, all of the Assignor’s right, title and interest in and to the trade marks identified on Schedule “A” attached hereto (hereinafter the “**Trademarks**”), including the pending trade mark applications and issued trade mark registrations identified on Schedule “A”, all of the Assignor’s rights of action against past infringement of the Trademarks and the right to receive payment of damages resulting therefrom, the ongoing and existing portion of the Assignor’s business to which the Trademarks pertain, and the goodwill of the business symbolized thereby;

AND WHEREAS, it is desired, by this document, to confirm the assignment of the aforesaid Trademarks, including the pending trade mark applications and issued trade mark registrations identified on Schedule “A”, all of the Assignor’s rights of action against past infringement of the Trademarks and the right to receive payment of damages resulting therefrom, the ongoing and existing portion of the Assignor’s business to which the Trademarks pertain, and the goodwill of the business symbolized thereby; and to provide evidence thereof for recordal in the Canadian Intellectual Property Office and the United State Patent and Trademark Office as may be expedient;

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor confirms that it has assigned and transferred to and does hereby assign and transfer to the Assignee all of the

Assignor's right, title and interest in and to the Trademarks including the pending trade mark applications and issued trade mark registrations identified on Schedule "A" attached hereto, all of the Assignor's rights of action against past infringement of the Trademarks and the right to receive payment of damages resulting therefrom, the ongoing and existing portion of the Assignor's business to which the Trademarks pertain, and the goodwill of the business symbolized thereby.

With respect to all U.S. trademark applications identified on Schedule "A" attached hereto, The Commissioner of Patents and Trademarks for the United States Patent and Trademark Office is requested to issue the Certificate of Registration to the Assignee.

With respect to all Canadian trade mark applications identified on Schedule "A" attached hereto, the Registrar of Trade-marks is requested to issue the Certificate of Registration to the Assignee.

This assignment is effective as of July 1, 2006.
