**THIS ASSIGNMENT** is made the 24<sup>th</sup> day of October 2006

**BETWEEN**

(hereinafter called "the Assignor")

**AND**

**Albion Colours Limited**

of Albion House, Rawdon Park, Green Lane, Yeadon, Leeds, West Yorkshire, LS19 7XX, United Kingdom (hereinafter called "the Assignee").

**WHEREAS**

(A) The Assignor is the proprietor in the United States of America of the Registered Trade Marks detailed on the attached schedule (hereinafter referred to as "the **Trade Marks**")

(B) The parties hereto have agreed that the Trade Marks and rights ancillary thereto should be transferred by the Assignor to the Assignee for the consideration hereinafter set forth.

**NOW THIS ASSIGNMENT WITNESSETH AS FOLLOWS:**

1. In consideration of the sum of £1 (one pound sterling) now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor hereby assigns to the Assignee with full title guarantee all its right, title and interest in and to the Trade Marks (including any renewals and extensions that may be granted thereof) together with the goodwill attaching to and symbolised by the Trade Marks and together with all rights of action, remedies, powers and benefits relating to the Trade Marks belonging or accrued including the right to sue for damages or other

remedies in respect of any infringement of such rights prior to the date hereof **TO HOLD** unto the Assignee absolutely.

2. The Assignor, at the request of the Assignor and at no cost to the Assignee save for out of pocket expenses reasonably incurred, shall:
- a) execute all such further documents as the Assignee may reasonably require to fully vest ownership of the Trade Marks in the Assignee; and
  - b) take all reasonable steps to assist the Assignee in the defence of opposition proceedings against the Trade Marks, including the preparation of evidence of continuous use of the Trade Marks by the Assignor and the Assignor's predecessors in title in relation to all the goods for which registration of the Trade Marks is sought; and
  - c) take all reasonable steps to assist the Assignee in the defence of any application for revocation or declaration of invalidity that may be filed in respect of the Trade Marks once registered.


