1. Defined terms & interpretation

Trade Marks means the trade mark registrations and trade mark applications set out in Schedule 1, including all unregistered or common law rights in those items, any goodwill associated with those items and, insofar as any copyright subsists in the Territory, any copyright subsisting in any logos in those items.

1.2 Interpretation

In this deed, except where the context otherwise requires:

- (a) the singular includes the plural and *vice versa*, and a gender includes other genders;
- (b) another grammatical form of a defined word or expression has a corresponding meaning;
- (c) a reference to a clause, paragraph, schedule or annexure is to a clause or paragraph of, or schedule or annexure to, this deed, and a reference to this deed includes any schedule or annexure;
- (d) the meaning of general words is not limited by specific examples introduced by **including**, **for example** or similar expressions; and
- (e) a rule of construction does not apply to the disadvantage of a party because the party was responsible for the preparation of this deed or any part of it.

2. Assignment of Trade Marks

The Assignor hereby assigns with full title guarantee to the Assignee absolutely and the Assignee accepts the assignment of, with effect from the Effective Date:

- (a) the Trade Marks, including any goodwill associated with those Trade Marks;
- (b) the rights to take all action necessary to recover damages or obtain any other remedies in respect of infringement of the Trade Marks, whether or not such infringement took place prior to the Effective Date of this deed, including the right to retain any damages obtained as a result of such action,

(Assignment).

3. Further assurances

- (a) Each party agrees to, at the request of the other party, execute or procure the execution (as a deed or otherwise) of all documents, forms and authorisations and to do or procure the doing of any and all such acts and things as may be reasonably necessary including the recording of the assignment of the Trade Marks and, where necessary, to execute any confirmation assignments where reasonably requested by either party and to give full effect to the Assignment and to vest in the Assignee the full benefit of the Trade Marks.

- (b) The Assignor shall give the Assignee, on the Assignee's request and at the Assignee's cost, all reasonable assistance with any proceedings which may be brought by or against the Assignee, against or by any third party in relation to the Trade Marks.

4. Miscellaneous

4.1 Alterations

This deed may be altered only in writing signed by each party.

4.2 Costs

Each party must pay its own costs of negotiating, preparing and executing this deed.

4.3 Counterparts

This deed may be executed in counterparts. All executed counterparts constitute one document.

4.4 Severability

A term or part of a term of this deed that is illegal or unenforceable may be severed from this deed and the remaining terms or parts of the term of this deed continue in force.

4.5 Waiver

A party does not waive a right, power or remedy if it fails to exercise or delays in exercising the right, power or remedy. A single or partial exercise of a right, power or remedy does not prevent another or further exercise of that or another right, power or remedy. A waiver of a right, power or remedy must be in writing and signed by the party giving the waiver.

4.6 Relationship

Except where this deed expressly states otherwise, it does not create a relationship of employment, trust, agency or partnership between the parties.

4.7 Governing law and jurisdiction

This deed is governed by the laws of England and each party irrevocably and unconditionally submits to the exclusive jurisdiction of the English courts.
