UNANIMOUS WRITTEN CONSENT OF BOARD OF DIRECTORS

OF

REPUBLIC FEDERAL SAVINGS AND LOAN ASSOCIATION

February 10, 1992

The undersigned, constituting all of the Directors of Republic Federal Savings and Loan Association (the "Association"), pursuant to Article III, Section 9 of the By-laws of the Association, do hereby consent to the adoption of the following Resolutions and the taking of the actions contemplated thereby:

WHEREAS, this Board of Directors has previously authorized the Association to transfer to Weyerhaeuser Company ("Weyerhaeuser") substantially all of the remainder of the Association's assets upon approval by the Office of Thrift Supervision ("OTS") of such transfer, all as further set forth in that certain Unanimous Written Consent of this Board of Directors dated December 16, 1991 (the "Previous Consent");

WHEREAS, the Association desires to transfer to Weyerhaeuser additional assets, as more fully described on Exhibit "A" hereto, upon the terms and conditions set forth in the Previous Consent, without separate consideration therefor;


NOW, THEREFORE, BE IT RESOLVED, that the Association is hereby authorized to transfer to Weyerhaeuser the Association's assets more fully described on Exhibit "A" hereto upon the terms and conditions set forth in the Previous Consent, without separate consideration therefor, upon approval by the OTS of such transfer;


RESOLVED, FURTHER, that any officer of the Association is hereby authorized to file, in the name and on behalf of the Association, additional filings with the OTS or an amendment to filings previously made with the OTS for approval of the transfer described in the Previous Consent as modified by the preceding Resolution.


