RELEASE OF TRADEMARK SECURITY AGREEMENT

WHEREAS, on January 28, 2005, THE OILGEAR COMPANY, a corporation organized and existing under the laws of the State of Wisconsin (the "Borrower") and LASALLE BUSINESS CREDIT, LLC, as Agent (the "Lender") entered into a Trademark Security Agreement (the "Security Agreement"), pursuant to which the Borrower assigned to the Lender certain of its right, title and interest in, to and under certain trademarks owned by the Borrower as further described therein (the "Collateral"), which Security Agreement was recorded with the United States Patent and Trademark Office on February 9, 2005 in Reel 3024, frame 0977; and


WHEREAS, the obligations secured by the Security Agreement have been paid in full and the Lender no longer claims a security interest or any other interest in the Collateral under the Security Agreement or otherwise.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender hereby expressly releases and discharges its security interest in and to the Collateral (which Collateral is further described on Schedule A attached hereto and incorporated herein) and reassigns, without representation, warranty or recourse, to Borrower all of the Lender's right, title and interest in and to the Collateral.

This Agreement may be executed in any number of duplicate originals or counterparts, each of such duplicate originals or counterparts shall be deemed to be an original and all taken together shall constitute but one and the same instrument.

IN WITNESS WHEREOF, the Lender has duly executed this Release of Trademark Security Agreement this 18<sup>th</sup> day of December, 2006.
