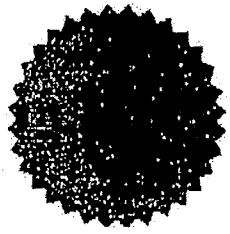


SIXTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF

Adam Miller, Chief Executive Officer of CyberU, Inc. (the "Corporation"), certifies that:

1. He is the duly elected Chief Executive Officer of the Corporation, a corporation organized and existing under the laws of the state of Delaware.

2. The name of this Corporation is CyberU, Inc. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on May 24, 1999, under the name "CyberU, Inc."
