Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of December 6, 2006 is made by Credit Suisse, Cayman Islands Branch (f/k/a Credit Suisse First Boston, acting through its Cayman Islands Branch) ("Bank"), as collateral agent ("Agent") for the financial institutions party to the Credit and Guaranty Agreement (Second Lien), dated as of October 21, 2004, among the financial institutions party thereto and the Agent, in favor of JW Aluminum Company, a Delaware corporation ("Grantor").


WHEREAS, Grantor entered into a Trademark Security Agreement, dated as of October 21, 2004 and recorded in the United States Patent and Trademark Office as of October 26, 2004 at Reel 3069, Frame 0878, pursuant to which Grantor granted to the Bank a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank has released, relinquished and discharged its security interest in, to and under the Released Trademarks, without representation or warranty of any kind.
