**RELEASE OF SECURITY INTERESTS**

FNBO further agrees to execute, deliver and, if necessary, file, or authorize the filing by LaSalle Bank National Association, a national banking association, on its own behalf and as agent for various lending institutions, any and all documents reasonably necessary to effect the release granted herein.
