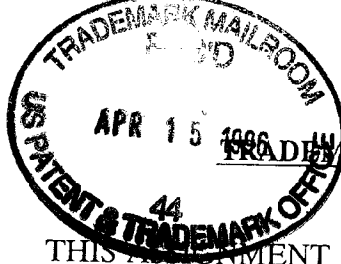

This

Assignment shall be binding upon the successors and assigns of Assignors, and shall inure to the benefit of the successors and assigns of Assignee.
