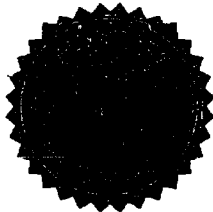

Aqua-Chem, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware does hereby certify that:

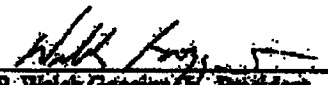
1. The name of the corporation is Aqua-Chem, Inc.
