

Amarillo hereby further assigns to RDS all of its rights to(a) all damages and other proceeds hereafter recovered or received in any infringement suit, settlement or other proceeding related to the Trademark Rights, (b) the right to sue for past, present and future infringements of the Trademark Rights, and (c) all other rights corresponding to the Trademarks including but not limited to all license agreements covering said Trademarks, and any existing or future applications and registrations related to the Trademark Rights throughout the world.
