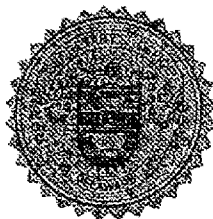

TRIGENESYS, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: The name of the corporation is TriGenesys, Inc. The date of the filing of the original Certificate of Incorporation of this corporation with the Secretary of State of the State of Delaware was October 26, 2005. The Certificate of Incorporation was amended and restated on June 7, 2006.

SECOND: The Certificate of Incorporation of the corporation is hereby amended by striking out the First Article thereof and by substituting in lieu of such Article the following new First Article:

"FIRST: The name of this corporation is CoGenesys, Inc. (the "*Corporation*")."

THIRD: The amendment of the Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
