**SECURITY AGREEMENT / NOTICE OF SECURITY INTEREST
(TRADEMARKS)
(Broin Enterprises Inc.)**

WHEREAS, BROIN ENTERPRISES INC., a South Dakota corporation, has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office, as more fully set forth on Schedule 1A (the "Trademarks");

WHEREAS, pursuant to the Credit Agreement dated as of December 28, 2006 (such agreement, as amended, restated, supplemented or otherwise modified from time to time, being hereinafter referred to as the "Credit Agreement") among Broin Companies, LLC, a South Dakota limited liability company (the "Borrower"), and the financial institutions from time to time party thereto (each a "Lender" and collectively, the "Lenders") and Bank of Oklahoma, National Association (in its individual capacity, "BOK"), as Administrative Agent (in such capacity, together with any successor in such capacity, the "Administrative Agent") have agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, Broin Enterprises, Inc., has entered into a Security Agreement dated as of December 28, 2006 (the "Security Agreement"), in favor of the Administrative Agent;

WHEREAS, pursuant to the Security Agreement, Broin Enterprises, Inc., has granted to the Administrative Agent for the benefit of the Lenders a continuing security interest in all right, title and interest of Broin Enterprises, Inc., in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Broin Enterprises, Inc., as collateral security for the full and complete payment and performance when due of the Obligations, hereby grants to the Administrative Agent for the benefit of the Lenders, a continuing security interest in the Collateral to secure the prompt payment, performance and for the benefit of itself and the lenders observance of the Obligations.

Broin Enterprises, Inc., does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, Broin Enterprises, Inc., has caused this Instrument to be duly executed by its officer thereunto duly authorized as of December 28, 2006.

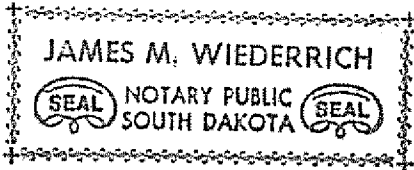
