WHEREAS, Assignor has agreed to execute such additional instruments as may be necessary or desirable to confirm and perfect such assignment to Assignee; and,


WHEREAS, Assignor and Assignee are desirous of making this Assignment a matter of record in the U.S. Patent and Trademark Office.

past, present and future damages, profits and costs, both in equity and law, for any infringement or infringements of the Marks accruing on or before the Date of Assignment.

IN WITNESS WHEREOF, Assignor has caused its duly authorized officer to execute this Assignment as of the date first above written.


