TRADEMARK ASSIGNMENT

This Assignment ("Assignment") is made effective as of December 15th, 2006 ("Effective Date") from LANDAU UNIFORMS, INCORPORATED, a Tennessee Corporation, with a business address at 8410 Sandidge Road, Olive Branch, MS 38654 ("ASSIGNOR") to THE WALKING COMPANY, a Delaware Corporation with a business address at 121 Gray Avenue, Santa Barbara, CA 93101 ("ASSIGNEE");

WHEREAS, ASSIGNOR has filed an application to register the mark FOOT WORX Ser. No. 76630936 ("the Mark") as may be further described in Exhibit 1, attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby in connection with the goods on which the Mark is used ("the Goods"); and


WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Mark, expressly reserving to ASSIGNOR all of its right, title, and interest in and to the marks LANDAU and THERAPY FOR YOUR FEET and expressly reserving to ASSIGNOR the goodwill of the business symbolized by ASSIGNOR's use of the marks LANDAU and THERAPY FOR YOUR FEET shown in the specimen filed in Ser No. 76630936 and which have been used together with the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR's right, title, and interest of whatever kind in and to the Mark, together with (1) the goodwill of the business relating to the Goods in respect upon which the Mark is used; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Mark. However, ASSIGNOR expressly reserves to itself and does not hereby convey, transfer, assign, deliver, and/or contribute to ASSIGNEE any of: (1) ASSIGNOR's right, title, and interest of whatever kind in and to the marks LANDAU and THERAPY FOR YOUR FEET; (2) the goodwill of the business relating to Goods in respect upon which the marks LANDAU and/or THERAPY FOR YOUR FEET are/is used or have been used; (3) any income, royalties, and/or damages hereafter due or payable to ASSIGNOR with respect to the marks LANDAU and/or THERAPY FOR YOUR FEET, including without limitation, damages, and payments for past or future infringements and misappropriations of the marks LANDAU and/or THERAPY FOR YOUR FEET; and/or (4) all rights to sue for past, present, and future infringements or misappropriations of the marks LANDAU and/or THERAPY FOR YOUR FEET.

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark, exclusive of any right, title, and interest in the marks LANDAU and/or THERAPY FOR YOUR FEET.
