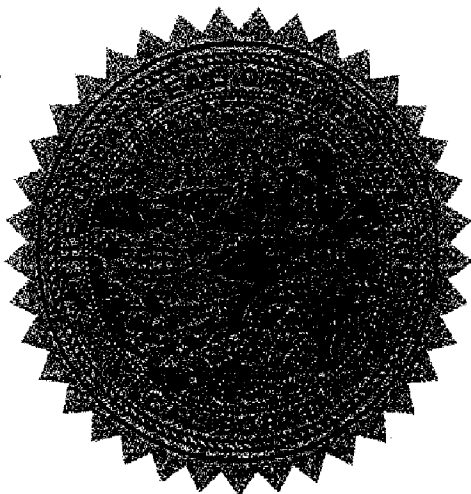

**CERTIFICATE OF AMENDMENT OF
ARTICLES OF INCORPORATION OF
SIERRA SEMICONDUCTOR CORPORATION**

The undersigned, James V. Diller and Neil J. Wolff, hereby certify that:

1. They are the Chairman of the Board of Directors and the Assistant Secretary, respectively, of Sierra Semiconductor Corporation, a California Corporation.
2. Article I of the Restated Articles of Incorporation of this corporation is amended to read as follows:

"I

The name of this corporation is PMC-Sierra, Inc."

3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is 29,152,950. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
