## TRADEMARK SECURITY AGREEMENT

**THIS TRADEMARK SECURITY AGREEMENT** dated as of December 1, 2006 (this Agreement"), by and among IGD INDUSTRIES, INC. ("Borrower"), an Iowa corporation, and its related and affiliated companies (the "Affiliates"): PRECISION REPLACEMENT PARTS CORPORATION, AUTO GLASS COMPONENTS, INC., IOWA GLASS DEPOT, INC., AUTO GLASS WAREHOUSE, INC., ALLIANCE CLAIMS SOLUTIONS, INC., AUTO GLASS CENTER, INC., MIDWEST GLAZING, LLC, AUTO GLASS CENTER OF KANSAS, INC., METAL DESIGN SYSTEMS, INC., FLEET PRIORITY SERVICES, LLC, GLASS INSTALLATIONS, LLC, RV CLAIMS SOLUTIONS, LLC, ALLIANCE DIVERSIFIED SERVICES, LLC, JC'S GLASS, LLC, GLOBE OF IOWA, LLC, KD INDUSTRIES, INC., MIDWEST AUTO GLASS CENTER, LLC, and ALLIED GLASS PRODUCTS HOLDINGS, INC. (jointly and severally with Borrower and the Affiliates, the "Grantors"), and BANKERS TRUST COMPANY, N.A. (of Cedar Rapids, Iowa), a national banking association ("Lender").

### WITNESSETH:

**WHEREAS**, Grantors, or any one or more of them, are the owners of the U.S. trademarks and trademark applications listed on the attached Schedule A (collectively the "Trademarks");

**WHEREAS**, pursuant to that certain Business Loan Agreement, dated as of December 1, 2006 (as may be amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), among Borrower and the Lender, the Lender has agreed, subject to the terms and conditions thereof, to make Loans (as such term is defined in the Loan Agreement) to the Borrower;

**WHEREAS**, under a Commercial Security Agreement dated as of December 1, 2006 ("Security Agreement") among Grantors and Lender, Grantors have granted to Lender a security interest in certain of their assets (including the Trademarks) to secure the performance of the respective obligations of Grantors under the Loan Agreement and the Corporate/LLC Group Continuing Guaranty (Unlimited) dated as of December 1, 2006 executed by all of the Affiliates; and

**WHEREAS**, Grantors and Lender by this instrument seek to confirm and make a record of the grant of a security interest in the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Grantors do hereby acknowledge that each Grantor has granted to Lender a security interest in all of Grantors' right, title and interest in, to, and under the Trademarks. Grantors also acknowledge and confirm that the rights and remedies of Lender with respect to the security interests in the Trademarks granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference.




