AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of December 6, 2006 by and between **COMERICA BANK**, successor by merger to Comerica Bank-California ("**Bank**") and **IBAHN CORPORATION**, a Delaware corporation (formerly called STSN, Inc., a Delaware corporation) ("**Parent**"), **IBAHN GENERAL HOLDINGS CORPORATION**, a Delaware corporation (formerly called STSN General Holdings, Inc., a Delaware corporation) ("**General Holdings**"), **IBAHN LEASING, LLC**, a Utah limited liability company (formerly called STSN Leasing, LLC, a Utah limited liability company) ("**iBAHN Leasing**"), **IBAHN INTERNATIONAL CORPORATION**, a Delaware corporation (formerly called STSN International, Inc., a Delaware corporation) ("**iBAHN International**") and **STSN UK LIMITED**, a company formed under the laws of England and Wales (company number 03952809) ("**STSN UK**") (collectively, the "**Grantors**").

RECITALS

A. Bank has agreed to make certain advances of money and to extend certain financial accommodations to Grantors (the "**Loans**") in the amounts and manner set forth in that certain Loan and Security Agreement by and between Bank and Grantors, dated as of February 10, 2003 (as amended and as the same may be further amended, modified or supplemented from time to time, the "**Loan Agreement**"; capitalized terms used herein are used as defined in the Loan Agreement).

B. Bank, Parent, General Holdings, iBAHN Leasing, and iBAHN International are parties to that certain Intellectual Property Security Agreement dated as of February 10, 2003 (the "**Original Intellectual Property Security Agreement**") pursuant to which Parent, General Holdings, iBAHN Leasing, and iBAHN International granted to Bank a security interest in certain Copyrights, Trademarks, and Patents to secure their obligations under the Loan Agreement. The parties desire to add STSN UK as a "Grantor" to the Original Intellectual Property Security Agreement and to amend and restate the Intellectual Property Security Agreement in its entirety as provided below.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, Grantors and Bank hereby amend and restate the Original Intellectual Property Security Agreement as follows:

AGREEMENT

To secure the obligations of Grantors under the Loan Agreement and under any other agreement now existing or hereafter arising between Bank and Grantors, each Grantor grants and pledges to Bank a security interest in all of such Grantor's right, title and interest in, to and under its Intellectual Property Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Schedules A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all

rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Bank under the Loan Agreement and the other Loan Documents. The rights and remedies of Bank with respect to the security interest granted hereby are in addition to those set forth in the Loan Agreement and the other Loan Documents, and those which are now or hereafter available to Bank as a matter of law or equity. Each right, power and remedy of Bank provided for herein or in the Loan Agreement or any of the Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Bank of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Loan Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Bank, of any or all other rights, powers or remedies.

Grantors represent and warrant that Exhibits A, B, and C attached hereto set forth any and all intellectual property rights in connection to which Grantors have registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

IN WITNESS WHEREOF, the parties have caused this Intellectual Property Security Agreement to be duly executed by its officers thereunto duly authorized as of the first date written above.
