RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of February 28, 2006 ("Effective Date") by and between Arnold Transportation Services, Inc., a Pennsylvania corporation, with its principal office at 9523 Florida Mining Road, Jacksonville, FL 32257 (the "Grantor"), and LaSalle Bank National Association, with its principal office at 135 South LaSalle Street, Chicago, IL 60603 (the "Administrative Agent").

WHEREAS, pursuant to the terms and conditions of that certain Patent and Trademark Security Agreement by and between the Grantor and the Administrative Agent dated as of December 8, 2004 (the "Trademark Security Agreement"), the Grantor granted to Administrative Agent a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by the Grantor, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto in each case, together with the goodwill associated therewith (collectively, the "Trademarks").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

The Administrative Agent shall, at the Grantor's expense, execute and deliver to the Grantor such further filings and releases as the Borrower may reasonably request to more fully and effectively effectuate the purposes of this Release.
