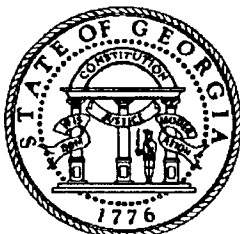

1. The name of the corporation is: Intertech Information Management, Inc.
2. Article I of the Articles of Incorporation shall be amended and restated in its entirety as follows:  
"The name of the corporation is eWebHealth Inc. (the "Corporation")."
3. The amendment to the corporation's name was adopted on August 24, 2004.
4. The amendment to the Articles of Incorporation was adopted by the board of directors without shareholder approval, such shareholder approval not being required pursuant to Section 14-2-1006 of the Code.


