UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

FIRST: The name of this corporation is Hi-Speed Checkweigher Co., Inc.

SECOND: Its certificate of incorporation was filed by the Department of State on the 8th day of April, 1953.

THIRD: The amendment effected by this certificate of amendment is as follows:
