ASSIGNMENT OF TRADEMARK

Box 69001, 1060 CA Amsterdam, The Netherlands ("Assignee"), the entire right, title and interest in and to all intellectual property rights owned by Assignor, including, but not limited to, the Assigned Mark and U.S. Trademark Registration No. 2,507,078.

NOW, THEREFORE, Assignor being fully cognizant of the aforesaid transaction, hereby executes this nunc pro tunc assignment in order to clarify ownership of the Assigned Mark and to confirm that the Assignor has and does hereby sell, assign, transfer and convey to the Assignee, its successors and assigns or their legal representatives, (a) the entire right, title and interest of the Assignor in and to the Assigned Mark, applications and registrations of the Assigned Mark, including but not limited to U.S. Trademark Registration No. 2,507,078, and all extensions and renewals thereof, together with the goodwill of the business in connection with which the Assigned Mark is and has been used, and (b) all rights, interest, claims, demands, recoverable in law or in equity, that the Assignor has or may have in profits and damages for past and future infringements of the

Assigned Mark, including, without limitation, the right to compromise, sue for and collect said profits and damages; the same to be held and enjoyed by the Assignee, its successor and assigns or their legal representatives, as fully and entirely a the same might or could have been held and enjoyed by the Assignor had this Assignment not been made.
